The PPL Electric Business Energy Efficiency Program will visit your facility to identify opportunities and determine eligibility.

Get started

1. Identify your custom project or reach out to our program team to determine eligibility for a custom energy efficiency incentive.
2. Submit an incentive application through the online portal. Pre-approval is required.
3. Install your equipment. A post on-site verification visit may be required.
4. Submit all required documentation.
5. Receive your incentive check.

Preapproval required

Preapproval is required for all custom projects. However, **pre-approval may be waived** on custom compressor and compressed air projects when project savings can still be accurately captured without pre-approval.

Frequently asked questions

Who receives the incentives?

The business customer named on the PPL Electric Utilities bill is by default the recipient of incentives. However, payment can be made to a third party; all that's needed is a signed document from the customer naming the payee.

Is there help available to create the calculators and complete the incentive application?

We offer one-on-one assistance through the entire process. Our team will review your plans, identify additional measures you may qualify for, and help complete your online application. Our team can also create calculators for your project. You will not be charged for any assistance we provide; it is all part of our program delivery.

What documents are required for incentive submission and pre-approval?

Required documents can be uploaded through our online portal at ppllectric.com/businessrebates.

Required documents include:

1. Copy of current PPL Electric Utilities bill
2. Cost Estimate (e.g., scope of work, proposal, or project quote)
3. Manufacturers' specification sheets for qualifying equipment
4. Incentive estimator(s), as needed for equipment and systems
5. Completed, signed W-9 with tax identification on the most current IRS version (Rev. 2018)
6. Completed, signed Third Party Authorization Form, if the payee is not the customer
