Eligible Custom Equipment

Custom projects are evaluated on an individual basis and must yield a minimum of 20 kW of Summer Peak Demand* savings at final review to be eligible for the bonus incentive.

Eligibility Requirements

- LP4 and LP5 customer rate codes only.
- Project must be submitted before June 30, 2024, with proper documentation:
 - PPL Electric Utility Bill
 - Payee W-9
 - 3rd Party Payee Form (if applicable)
 - Spec Sheets
 - Cost Estimate
 - Completed Estimator (prescriptive projects only)
- Project must be submitted between January 1, 2024 and June 30, 2024 to receive the bonus incentive.
- Project must complete construction in 2024.
- Final project documentation must be submitted by January 31, 2025.
