Your path to savings



Prescriptive and custom incentives increase the ROI of installing energy-efficient equipment. Eligible upgrades include, but are not limited to:

^{**}Pre-approval is not required for prescriptive applications. Project pre-approval continues to be recommended and encouraged to accurately calculate savings and incentives. However, pre-approval may be waived by PPL Electric on custom projects when project savings can still be accurately captured without pre-approval. The Direct Discount Program requires pre-approval prior to construction beginning on all projects other than HVAC tune-ups and smart thermostats. Pre-approval means that a project application must be submitted in good order and receive a pre-approval letter before construction begins. All projects must be submitted, with all documentation in good order, within 180 days of the project completion date. Incentives are capped at 50% of project cost, up to \$500,000. Incentives for Direct Discount Program are capped at 80%.

^{**}Standard prescriptive application required. HVAC tune-up applications must include before and after cleaning photos, and name plate photo in place of specification sheets. Customers cannot have a current HVAC maintenance contract or received a tune-up in the last 3 years to be eligible.

Our Direct Discount Program lets small businesses with a GS1 or GS3 rate code save \$0.10 per kWh on eligible refrigeration, compressed air, HVAC upgrades and tune-ups, smart thermostats, domestic hot water and lighting projects — covering up to 80% of the project cost.

Planning a new construction project or major renovation? We offer assistance and incentives for equipment beyond the code minimums.

All PPL Electric Utilities non-residential customers can get **instant discounts** on qualified lighting, HVAC, food service and agriculture products and equipment when you purchase from local participating distributors. Just provide your PPL Electric Utilities account number. No forms or applications required.

Your step-by-step guide to savings

We're here to guide you through every step of the application process and help you identify the incentive or program that fits your business best. Here's how it works:

- Find a contractor. Use our handy Find a Contractor tool on our website to connect with local experts and discuss eligible measures.
- Set up an account and apply for your rebate online at pplelectric.com/businessrebates.
- **Reserve your funds** with approval from our program team and, if required, get a pre-verification.
- Install your energy-efficient equipment or systems.
- **Submit** your final application and supporting documentation (itemized invoice, scope changes, etc.) as needed.
- **Prepare for final review.** Watch for email requests for additional documentation or a post-site verification, if required.
- **Receive your incentive check** in approximately 4–6 weeks after completion of final review.
